

PRIVACY POLICY

WHAT INFORMATION DO WE COLLECT?

DO WE DISCLOSE INFORMATION TO OUTSIDE PARTIES?

Unless otherwise stated in this privacy policy, we do not sell, trade or otherwise transfer your Personal Information to outside parties. This does not include trusted third parties who assist us in operating our Site, conducting our business, or serving you, so long as those parties agree to keep this information confidential. We may also release your information when we believe in good faith that such release is appropriate to comply with the law, to enforce our Site policies, or to protect our or others' rights, property and safety.

We use non-personally identifiable information in the aggregate so that we can improve the Site and for business and administrative purposes. We may use or share such aggregated data with third parties for any purpose.
